



COVID-19 Health Verification

The University of Lynchburg will be gradually reopening over the summer and plans to hold classes on campus beginning on Aug. 12. All members of the University community and visitors share the responsibility of ensuring a safe return to campus. **Effective immediately, all who plan to be on campus for any period of time must follow daily screening and temperature-check protocols before coming to campus.** This is in addition to required masks or face coverings and adherence to current social distancing guidelines.

Screening Questions

Faculty, staff, and students are urged to use the [LiveSafe](#) app each day to screen for COVID-19 symptoms. The app will instruct each individual if they should stay home or report to campus at the completion of the screening questions. Symptoms and questions include:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

Are you experiencing any of the COVID-19 related symptoms noted above?

Are you living with or caring for an individual who is a suspected or confirmed case of COVID-19?

Have you been in contact with anyone known or suspected to have COVID-19 in the last 14 days?

Have you tested positive for COVID-19?

Temperature checks at home

Faculty, staff, and students are asked to take their temperature each day before leaving their residence. A temperature greater than or equal to 100.4 F is considered a fever and the individual is not to report to campus. Students who reside on campus and record a fever may not leave their room, apartment, or house.

- Students with a temperature must contact Student Health at 434.544.8647 (8:30 a.m.-5 p.m. Monday-Friday) ; the Centra Health COVID-19 hotline 24/7 to speak with a nurse: 434.200.1225; **and** their professor or academic advisor.
- Faculty and staff with a temperature must contact their direct supervisors.

Faculty, staff, and students who screen negative on all COVID questions and record a temperature below 100.4 F may report to campus as required.

Temperature checks on campus

Once classes resume, faculty, staff, and students will have their temperatures screened on campus once each day. Temperature screening will occur with automated kiosk scanners or by handheld no-contact thermometers. Individuals should use one of these devices before entering buildings with large congregations of people.

- Those who develop illness or a temperature of 100.4 F or greater during the day must leave campus immediately and contact the appropriate faculty, advisors, and/or supervisors as outlined above.

COVID-19 Health Verification Acknowledgement

Effective immediately, all who plan to be on the University of Lynchburg campus for any period of time must follow daily health verification and temperature-check protocols before reporting to campus. If you have not used the LiveSafe app to verify your health status, please complete the following checklist, sign, and date this form, and provide the completed form upon arrival on campus. In addition to completing this COVID-19 screening, all students, faculty, staff, and visitors must wear a mask or face covering and adhere to current social distancing guidelines while on University property.

Please check all boxes that apply:

- ☐ Student/Faculty/Staff/Visitor has a fever of 100.4 F **and** signs/symptoms of lower respiratory illness (e.g. cough or shortness of breath).
- ☐ Student/Faculty/Staff/Visitor has had **close contact** with a confirmed COVID-19 patient within the last 14 days.
- ☐ Student/Faculty/Staff/Visitor has a fever of 100.4 F **or** signs/symptoms of lower respiratory illness **and** a history of travel from affected geographic regions within 14 days of symptom onset.
- ☐ Student/Faculty/Staff/Visitor **does not** meet any of the above criteria.

STUDENTS: If any of the first three boxes are checked, you must contact Student Health at 434.544.8647 (8:30 a.m.-5 p.m. Monday-Friday) **and** alert your professor or academic advisor.

FACULTY, STAFF: If any of the first three boxes are checked, you must contact your supervisor and seek medical advice from your primary care provider.

VISITORS: If any of the first three boxes are checked, you will not be permitted to enter University property.
